AltaGas Utilities 2021 Franchise Fee Res.211-2020 Deputy Mayor Roy Krahulec moves there will be no change to the 2021 Franchise Fee percentage with AltaGas Utilities and the fee will remain the same at 8%. Carried.

Deputy Mayor Roy Krahulec moves to submit an application to Alberta Municipal Affairs by October 1, 2020 under the Municipal Stimulus Program (MSP) for the Project Titled: Main Street Rehabilitation (50th Street) Paving with a project cost of \$195,000.00 with construction to begin in the Year 2021; and approve MPE Engineering to engineer the project for the Village of Waskatenau. Carried.

The allocated MSP funding the Village of Waskatenau is eligible to receive is \$50,000.00.

Memorandum of Understanding Ukraine Twinning Initiative The Smoky Lake Regional Community Development Committee (RCDC) signed a municipal twinning agreement in the form of a Memorandum of Understanding (MOU) in January 2020. The next steps will be the official signing of the MOU with the Reeve of the District of Kosiv (Ukraine) as well as the Mayor of the Town of Kosiv. The signing on behalf of our Ukrainian partners would be completed on September 30, 2020 by way of a virtual signing meeting. Once completed we would exchange thoughts on possible ways to strengthen the relationship and cooperation between our communities. Mayor Caron will attend the virtual signing of the Agreement on behalf of the Village of Waskatenau.

Ditch Easement Res.216-2020

Mayor Casey Caron moves to send a letter to the Smoky Lake County advising the Village of Waskatenau requires written notification from the Smoky Lake County regarding the installation of a new drainage ditch through the Village lands and to provide the Village with a site map of the location on the west side of the Village near the CN rail.
