Council requested a letter be sent to the owner at 5128 – 47 Street advising them to put a reasonable number of bags in their bin for Village pickup and to take any excess bags to the landfill on Saturdays, also to include in the letter the Village only picks up waste generated from the Village at your residence only. Council requested a copy of our Garbage Bylaw #632/2011 be attached to the letter along with the picture taken showing the bags spilling out the bin and stacked along side of the bin. Public Works advised this is a weekly problem at this residence.
