The streets improvements project has been completed by Lafarge Construction. We are waiting to complete the final inspection with WSP Canada (Engineer) and Lafarge Construction. We are also waiting for an invoice for the project. Most of the street crack fills as per the contract have been done on the east side of 50th street. There is more crack filling to be completed for the remainder of the Village. Council is satisfied with the Contactor work and the project. All transitions with driveways and alleys are completed. There is one valve that must be uncovered. The Village will hold on to the old materials of the asphalt and gravel mix currently stored at the Waskatenau Transfer Site. Administration will contact LaFarge Construction to obtain a cost estimate to have them finish the remainder of the street crack fills.
