Julie Sawchuk & Shawnalee Shwetz attended the meeting to Shwetz, Shawnalee discuss the library updates.

- The Village received a cost estimate for an engineer inspection to determine the book weight load for the floor at the ECS building at a cost of \$3,000.00-\$10,000.00. A carpenter could also provide us with in the information.
- Other cost estimates for shingles/roof, plumbing, electrical, heating and exterior were discussed.
- Library Board feels they still would like a stand- alone building for the library so they can offer a variety of community programs.
- The Library has applied for grants for the ECS building and wishes to pursue building renovations. Grants applied are both capital and operational.
- Council concerned with low user rate and operating costs i.e. rent, utilities, general maintenance.
- Library requires supernet activation in order to communicate with all the other library systems and NLLS.
- An agreement must be discussed with Lakeland Catholic School Board should the Library Board proceed with the ECS Building - rental/purchase.
- Library will move into the Village Council Chambers as a temporary location until another building can be located. The Village Office already has supernet into the building.
- Library can downsize to fit Council Chambers and room could also be utilized by Council for meetings.
- No renovations to Council Chambers. Renovations to expand size of room may be done in the future should the library not relocate.
